



## 2025 TRANSPec GT OIL PARARORANGI ROAD GRAVEL SPRINT - SAFETY PLAN

### 1. INTRODUCTION

- 1.1 Authority:** In accordance with the current New Zealand Motorsport Manual Appendix Two Schedule H this plan sets out the systems that are in place and specifies the processes to use in the event of any injury accident for competitors, officials and the public. The Motorsport NZ Permit Number is 240550
- 1.2 Event Control Headquarters:** The event will be held on Pararorangi Road, Waituna West, Feilding, with documentation at the event HQ situated in the service area paddock north of the weir

- 1.4 Event Intervention:** Recovery vehicle and double cab ute at the start line and a minimum of one other vehicle at the mid-point. Both vehicles will be equipped with fire extinguishers and tow strops
- 1.5 Communication Network:** Communication will be by radio from Event Control. Radios will be issued to the Clerk of the Course, start line, mid-point and finish marshals, rescue, chief medical officer and the event organizer. A radio check will be performed before the sighting run.

### 2. VENUE

- 2.1 Location:** Pararorangi Road, Waituna West, Feilding  
( grid reference 40°03'14.6"S 175°35'57.3"E ). 27 km north of Feilding.
- 2.2 Course - Length and Surface:** The length of course is approximately 4.0km, 100% gravel.
- 2.3 Vehicle Access and Egress to Venue:** Access to the venue is via Williamson Road off SH54 or Makino Road which links to Short Road and Dunolly Road.
- 2.4 Venue Security:**
- (1) **Road Closure:** Manawatu District Council, Cat McIntyre 06 323 0000
    - (a) **Road closure schedule and conditions:** Closure from 8.00am to 5.00pm under Section 342 (b) and the 10<sup>th</sup> Schedule of the Local Government Act 1974
    - (b) **Road closure marshal requirements:** Two marshals situated at the Arapata Road-Pararorangi Road junction will control the road closure from 0800 to the conclusion of the event

(2) **Spectator Control:** Spectators will be advised of safe viewing practices at Control HQ.

**2.5 Competition manning levels:**

- (a) **Start line:** Two marshals, one to hold waiting competitors and the other to line the cars up
- (b) **Finish line:** Two marshals, one observing the finish and the other recording and radioing results
- (c) **Intermediate Marshal posts:** A minimum of two intermediate posts at approximately 1.5km and 3.0km into the run

**2.6 Course Clearance:** Course clearances will be performed by the recovery vehicle at the conclusion of each run and after any incident that stops a run.

**3. SPECTATOR AREAS**

There are no organized spectator areas. Spectators will be handed a copy of the Motorsport NZ Rally Safety brochure at Control HQ advising best viewing practice.

**4. SAFETY OF OFFICIALS AND COMPETITORS**

**4.1 Officials and Marshal Training Briefings:** A marshal briefing will be undertaken to ensure that all officials controlling the event and particularly those at spectator viewing points are fully aware of safety requirements. Radio checks will be managed by the Clerk of the Course

**4.2 Competitors Safety:** The event will be conducted in accordance with the requirements of the current Appendix Five Schedule C Part 1 Article 7. A competitors briefing will be held prior to the commencement of the event outlining the event procedures with emphasis on all safety aspects.
