






## NOTIFICATION OF STEWARDS DECISION

<b>COMPOSITION OF PANEL:</b>  Due to a conflict of interest TERRY CARKEEK (Chairperson) removed himself from the panel and STU ANDREWS was co-opted for this hearing.			
<b>ALLEGED RULE BREACH:</b> It is alleged that you have:			
<ul style="list-style-type: none"> <li>Formula First Technical Regulations 3.2 and 3.4 in that your car was presented without engine seals.</li> </ul>			
<b>FINDING:</b> The Stewards find that:			
<ul style="list-style-type: none"> <li>Whilst undertaking repairs on 27 February you accidentally broke the seals attached to your engine.</li> <li>This was immediately reported to Morris Thompson who advised that you should continue the repair but that a penalty would be imposed by the Clerk of the Course at your next meeting.</li> <li>An inspection was undertaken at Manfeild on 4 April and the missing seals were reported.</li> <li>A hearing by the Clerk of the Course was undertaken where you admitted to the breakage. He accepted your explanation that it was an error.</li> <li>When considering his subsequent penalty he took this admission and explanation into account and only imposed the minimum penalty possible.</li> <li>The Stewards agreed with this approach.</li> </ul>			
<b>PENALTY TO BE APPLIED:</b> The Stewards rule that:			
<ul style="list-style-type: none"> <li>CotC decision D001 is upheld</li> <li>Your protest fee is forfeited.</li> </ul>
